- Mayor Wagoner informed the commission the current city clerk/treasurer, Carol Strother, submitted a letter of resignation due to her husband accepting a new job position located in Missouri and their eventual move to Missouri. Mayor Wagoner read Clerk Strother's letter of resignation stating her intended last day of employment will be Thursday, 2/27/2020. Commissioner Reese made a motion to accept City Clerk Strother's letter of resignation; Commissioner Southworth seconded the motion; all in favor; motion passes.
- Mayor Wagoner talked with the commission about the continued need for a new city attorney. Matthew
 Stephens, former city attorney, submitted his resignation letter at the previous December 23, 2019
 Regular Commission Meeting due to his acceptance of a position in the department of local government
 in Frankfort.
- Mayor Wagoner stated both open positions needed to be advertised.
