	property to be boarded up and made safe. Commissioner Reese made a motion to approve up to \$3500 to board			
	up 3 abandoned properties located in the city; commission discussed; Commissioner Reese withdrew the motion.			
	Commissioner Reese made a motion to table the vote and reintroduce the code enforcement plan at the Special			
	Meeting scheduled for Thursday, 1/30/19 at 2pm; Commissioner Southworth seconded the motion; all in favor;

Commissioner Reese and Commissioner Cannon agreed to take on the task of securing a job description for the Maintenance/Repair position.

	Mayor Wagoner introduced Scott Turner with SCAD (Scott Countians Against Drugs) who presented to the commission an overview of the program and the purpose of prescription drug drop-off box that was delivered to the City of Sadieville.
