☐ CALL TO ORDER

- Mayor Wagoner called the August 28, 2023, Regular Meeting to order at 6:00 p.m.
- Mayor Wagoner invited everyone to participate in a moment of silence.
- City Clerk Centers conducted the roll call.


- Mayor Wagoner: Present

- Commissioner Freeman made a motion to approve the minutes for the July 24, 2023, regular meeting and the August 16, 2023, special meeting; Commissioner Cornett seconded the motion; all in favor; motion passed.
- Commissioner Halsey made a motion to approve the financial reports with the addition of \$2991.68 for Attorney Obermeyer and Integrated Security Solutions; Commissioner Cornett seconded the motion; all in favor; motion passed.
- **Mayor:** Mayor Wagoner thanked Commissioner Halsey for all her hard work on the flower barrels and the flowers along Warring Pavilion. He told Commissioner Stamper that the splash pad is a big hit. He stated that the Party in the Park was phenomenal, everyone in attendance seemed to have a good time. Unfortunately, the weather did not allow the fireworks. GMWSS has approved a sewer hook up for the dollar store at the interstate.
- **City Attorney:** Commissioner Cornett made a motion to approve \$700.00 deposit for the Scott County Master Commissioner for the Fightmaster property foreclosure to be scheduled; Commissioner Stamper seconded the motion; all in favor; motion passed.
- **Attorney:** Mayor Wagoner made a motion to move forward with the demolition of 145 Vine Street with Wood Line Fencing tentatively; Commissioner Stamper seconded the motion; all in favor; motion passed.
- **Attorney:** Commissioner Cornett made a motion to approve sending the letter regarding the voting centers from the commission to the Georgetown News Graphic Letter to the Editor; Commissioner Halsey seconded the motion; all in favor; motion passed.

- **Public Works:** Commissioner Cornett has been discussing with Commissioner Freeman on having the inmates help stain the deck and do some painting.
- **Parks & Recreation:** The volleyball net was caught in the mower and torn up. The mowing company will be asked to reimburse the cost of the net.
- **Parks & Recreation:** Mayor Wagoner stated that benches can be purchased for approximately \$50. The city is asking for donations for the benches.
- **Parks & Recreation:** Commissioner Halsey suggested getting some type of waterproof box to store the first aid kit at the splash pad. Maintenance will begin walling in the manifold shed.
- **Public Safety:** Wood Line Fencing will repair the camera wire at the park.
- **Public Safety:** Commissioner Halsey suggested that the city set a day and time for monthly workshops. She will check with all elected officials to find the best time for those and will revisit this issue at the September meeting.
- **Public Safety:** They will revisit the plexiglass for the police department windows.
- **Public Safety:** Commissioner Halsey received a phone call from a citizen that would like to see placards on all historical buildings throughout the city. Mayor Wagoner stated that in previous years the buildings had them, but they have been removed since then. The citizen also suggested white string lights through the town to make it more festive. Commissioner Halsey also brought up purchasing a live tree to plant in the park for the city Christmas tree, she got an estimate for \$400 for the tree, \$100 delivery and \$200 to set out.
- **Streets, Trails & Walkways:** Nothing to report.
- **City Clerk Report:** Commissioner Cornett made a motion to approve \$50.00 for the purchase of a printing calculator for city hall; Commissioner Stamper seconded the motion; all in favor; motion passed.
- **City Clerk Report:** City Clerk Centers has earned her Certified Kentucky Municipal Clerk designation. She thanked the commission for their support.
- **City Clerk Report:** Thirty-one property liens have been filed on past due property taxes.
- **City Clerk Report:** The insurance company called, and they noticed that the pavilion at Veteran's Park is not insured. The commission agreed to insure it.
- **City Clerk Report:** The commission agreed to have a city-wide yard sale to correspond with the Boone's Way Yard Sale on October 6 and 7.
- **City Clerk Report:** City Clerk Centers asked if the commission wants the events committee to move forward on planning Halloween and Christmas. The commission agreed to move forward with planning both events. Mayor Wagoner stated that it would be nice to have more volunteers for the events.
- Mayor Wagoner made a motion to adjourn the meeting at 7:40 p.m.; Commissioner Cornett seconded the motion; all in favor; motion passes.
