

- Mayor Wagoner determined a quorum was present.
- Mayor Wagoner explained this had to be called as a special meeting as the office was closed on the regularly scheduled meeting day in observance of Christmas day.
- Georgetown-Scott County Planning and Zoning could not make the meeting tonight. For the comprehensive plan, the region went from 3200 acres to 1500 acres which would allow us to zero in on the area around the interstate. It does not affect any new businesses that are looking to locate there.
- Commissioner Stamper made a motion to approve the meeting minutes for November 28, 2022; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
- Commissioner Stamper made a motion to approve the December 2022 financial reports with the addition of two unpaid bills, \$75.00 for Attorney Jason Obermeyer and \$1,050.84 for Kool Breeze Automotive; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
- Attorney Obermeyer sworn in Phyllis Morris, Dana Cannon, and Samantha White as members of the Sadieville Ethics Commission.
- The representative for the splash pad installation could not make the meeting tonight.
- Paint colors for the walls and ceiling for city hall were discussed.
- Commissioner Stamper made a motion to approve up to \$100.00 for miscellaneous materials to install speed limit signs; Commissioner Halsey seconded the motion; all in favor; motion passed.

- Commissioner Stanley made a motion to approve up to \$1500.00 for the purchase of up to two laptops for the police department; Commissioner Halsey seconded the motion; all in favor; motion passed.
- Commissioner Stamper made a motion to approve \$500.00 for the city's annual website renewal fee; Commissioner Halsey seconded the motion; all in favor; motion passed.
- Commissioner Stamper made a motion to close city hall for ½ day on December 29 in observance of New Years Eve and to close city hall for the full day on January 2nd in observance of New Years Day; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
- Commissioner Stamper made a motion to adjourn the meeting at 6:41 p.m.; Commissioner Stanley seconded the motion; all in favor; motion passed.
