□ CALL TO ORDER

- Mayor Wagoner called the January 24, 2022, Regular Meeting to order at 6:00 p.m.
- Mayor Wagoner invited everyone to participate in a moment of silence.
- City Clerk Centers conducted the roll call.

- Mayor Wagoner determined a quorum was present.
 - Commissioner Stamper made a motion to approve the minutes for the December 27, 2021, regular meeting; Commissioner Halsey seconded the motion; all in favor; motion passed.
 - Commissioner Stamper made a motion to accept the financial reports with the addition of the unpaid bills for Stryker \$3206.67, Attorney Obermeyer for \$562.50 and HMB Engineering for \$3466; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
 - **Mayor:** We will try to move quickly tonight due to the increase in COVID numbers. Looking at the financial reports, the city was sitting with approximately \$345,000 and this year we added \$100,000 to that. We have been making good deposits, with the insurance premium taxes and the hotspot payments are starting to show a difference. Reminder that budget time is coming up, please be thinking about those, he would like to have a budget workshop in March, a first reading in April and a final reading in May. He will wait until more information is available to discuss paying employees with ARPA monies due to COVID absences. He has been getting interest in a community center. This will be something to investigate more in the future. The Bluegrass Ad has grants available for this type of project.
 - Commissioner Stamper made a motion to appoint Josh Cornett to the vacancy on the Scott County Code Enforcement Board for the Sadieville representative; Commissioner Halsey seconded the motion; roll call vote:



- Mayor Wagoner made a motion to approve \$300 to run franchise bid for broadband in paper; Commissioner Stamper seconded the motion; all in favor; motion passes. Due to a constitutional requirement, the city still must run an advertisement for the franchise bid even though the county has accepted Spectrum as the broadband provider.
- **City Attorney:** Nothing to report currently.
- **Public Safety:** Nothing to report currently.
- **Public Works:** Nothing to report currently.
- **Parks & Recreation:** Commissioner Stamper made a motion to approve \$350 for the Easter event; Commissioner Halsey seconded the motion; all in favor; motion passes.
- **Streets, Trails and Walkways:** Nothing to report currently.
- **City Clerk:** Each commissioner has spreadsheets in their packets, detailing breakdowns of the American Water Environmental Grant, Cybersecurity Grant and the ARPA monies. She is currently applying for two different scholarships to attend the clerks institute this year. The first quarter 2022 newsletter needs to go out soon if there is anything to add let her know. She asked if the city would like to participate in the US25 yard sale this year on June 3rd and 4th, they would.
- A citizen volunteered to help with the city beautification, such as flowers.
- Mayor Wagoner made a motion to adjourn the meeting at 6:29 p.m.; Commissioner Stamper seconded the motion; all in favor; motion passes.
