- Mayor Wagoner introduced the Municipal Road Aid Cooperative Program Agreement.

- Mayor Wagoner brought forth the sewer capacity issue. The City of Georgetown (Mayor Prather) has stated that the sewer is at full capacity and no new developments at the interstate exchange will be able to hook onto the sewer. The Mayor has asked the commission to approve HMB to help the city regarding the sewer issue.

- Commissioner Stamper made a motion to approve the agreement for engineering services for continuing service for the city regarding utility infrastructure with a cap of \$5000 using ARPA money; Commissioner Halsey seconded the motion; roll call vote; motion passed.



- Commissioner Stamper made a motion to approve \$250 for a shelf for the police department basement to store supplies for park bathrooms and cleaning items; Commissioner Halsey seconded the motion; all in favor; motion passed.
- Commissioner Stamper made a motion to approve \$900 for two shelving units for the record storage room at City Hall; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
- Mayor Wagoner made a motion to approve refund checks for internet customers that prepaid; Commissioner Stamper seconded; all in favor; motion passed.
- Commissioner Epperson-Stanley made a motion to approve \$1500 for Christmas train rental; Commissioner Stamper seconded the motion; all in favor; motion passed.
- City Clerk asked the commission is they will allow set up on Main Street for the city-wide yard sale. Chief Bruner did not see an issue with it as long as they are out of the roadway, preferably the parking area beside the railroad, and they must clean up after. The city attorney will check to see if the city can sell surplus items at a yard sale.
- Mayor Wagoner made a motion to approve \$500 for the Ky Municipal Clerk institute to be reimbursed after attendance; Commissioner Stamper seconded the motion; all in favor; motion passed.
- Mayor Wagoner made a motion to adjourn the meeting at 11:13 a.m.; Commissioner Stamper seconded the motion; all in favor; motion passes.
