

- Commissioner Stamper made a motion to approve the minutes for the October 24, 2022, regular meeting; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
- Commissioner Stamper made a motion to approve the financial reports with the addition of \$191.13 for Attorney Obermeyer; Commissioner Halsey seconded the motion; all in favor; motion passed.
- **Mayor:** Mayor Wagoner made a motion to approve up to \$1000 to pay for the city officials academy training; Commissioner Stamper seconded the motion; all in favor; motion passed.
- **Mayor:** Mayor Wagoner made a motion to set the special meeting for December to December 27, 2022, at 6:00pm and to close city hall on December 26, 2022, in observance of Christmas day; Commissioner Stamper seconded the motion; all in favor; motion passed.
- **Mayor:** Commissioner Stamper made a motion to appoint Dana Cannon, Phyllis Morris, and Samantha White to the Board of Ethics; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
- **Mayor:** Commissioner Stamper made a motion to approve \$500 for the city to become a Certified City of Ethics through KLC with training; Commissioner Halsey seconded the motion; all in favor; motion passed.
- **City Attorney:** Attorney Obermeyer read Resolution 2022-03, Hazard Mitigation. Commissioner Epperson-Stanley made a motion to approve the resolution; Commissioner Stamper seconded the motion; all in favor; motion passed.

- **City Attorney:** Commissioner Stamper made a motion to approve the mailing of a letter to a previous employee regarding a retirement issue; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
- **Public Safety:** Commissioner Stamper made a motion to approve up to \$1500 to purchase new tires for Chief Bruner's cruiser; Commissioner Halsey seconded the motion; all in favor; motion passed.
- **Public Safety:** There was a discussion regarding the Crown Vic cruiser.
- **Parks & Recreation:** Commissioner Stamper made a motion to pay a \$12,000 down payment from the previously approved money for splash pad; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
- **Public Works:** Christmas decorations are being completed; all electric has been checked. There are a few minor repairs that need to be done on the caboose and Commissioner Epperson-Stanley is working with maintenance on these issues.
- **Streets, Trails and Walkways:** Commissioner Stanley is absent.
- **City Clerk Report:** Mayor Wagoner made a motion to approve \$225 to pay annual dues for the Kentucky Municipal Clerks Association and the International Institute of Municipal Clerks; Commissioner Stamper seconded the motion; all in favor; motion passed.
- **City Clerk Report:** Commissioner Stamper made a motion to approve \$500 to pay the annual fee for Quickbooks; Commissioner Halsey seconded the motion; all in favor; motion passed.
- **Citizen Comment:** A citizen asked about the sewer bill increase and a discussion regarding that issue ensued.
- Commissioner Stamper made a motion to adjourn the meeting at 7:27 p.m.; Commissioner Halsey seconded the motion; all in favor; motion passes.
