□ CALL TO ORDER


- Mayor Wagoner called the October 24, 2022, Regular Meeting to order at 6:00 p.m.
- Mayor Wagoner invited everyone to participate in a moment of silence.

- Mayor Wagoner determined a quorum was present.
 - Commissioner Stamper made a motion to approve the minutes for the September 26, 2022, regular meeting; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
 - Commissioner Stamper made a motion to approve the minutes for the October 13, 2022, special meeting; Commissioner Halsey seconded the motion; all in favor; motion passed.
 - Commissioner Stamper made a motion to approve the financial reports with the addition of \$673.12 for Attorney Obermeyer, \$56.00 for Wex, and \$108.37 for Jennifer Halsey; Commissioner Stanley seconded the motion; all in favor; motion passed.
 - Mayor Wagoner presented Tyler Gunnell with the Sadieville Superhero certificate in recognition of his good character regarding animal welfare.
 - Magistrate Rick Hostetler gave an update on the Spectrum broadband for Scott County.
 - **City Attorney:** Brownsfield Assessment is completed on Sadieville school. We are just waiting to see if the city can get the property in their name to move forward. Mayor Wagoner asked the commission to brainstorm about a memorial or something like that to remember the school.
 - **Public Safety:** Commissioner Stamper made a motion to approve up to \$500 for an electrician to assist Integrated Security Services with installing the new security camera; Commissioner Halsey seconded the motion; all in favor; motion passed.
 - **Public Safety:** Mayor Wagoner made a motion to approve the extra \$23/month and a \$99 one-time installation fee for AT&T to replace the current phone and internet lines at the police station; Commissioner Stamper seconded the motion; all in favor; motion passed.

- **Parks & Recreation:** Maintenance will be resetting the end fence on the gravel parking lot side at the park closest to Pike Street at a 45 degree angle to allow cars to enter the field for events.
- **Parks & Recreation:** Park bathrooms will be closed at the beginning of November.
- **Public Works:** Mayor Wagoner made a motion to approve a total mowing increase of \$78.75 (split over all properties) for the 2023 mowing season with Seasons Lawncare; Commissioner Stamper seconded the motion; all in favor; motion passed.
- **Public Works:** Commissioner Epperson-Stanley made a motion to approve up to \$150 to purchase materials to repair the handrail on the city hall deck; Commissioner Stamper seconded the motion; all in favor; motion passed.
- **Public Works:** Mayor Wagoner made a motion to approve up to \$2500 for painting the inside of city hall; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
- **Streets, Trails and Walkways:** Commissioner Stanley made a motion to renew the snow removal contract with Seasons Lawncare for the 2022/2023 season; Commissioner Stamper seconded the motion; all in favor; motion passed.
- **Streets, Trails and Walkways:** Commissioner Stanley made a motion to approve up to \$300 to purchase 15mph signs and 'children at play' signs for Burgess Heights; Commissioner Halsey seconded the motion; all in favor; motion passed.
- **City Clerk Report:** Commissioner Stamper made a motion to move forward with the city applying for Discover credit cards to replace the cancelled PNC credit cards; Commissioner Stanley seconded the motion; all in favor; motion passed.
- **City Clerk Report:** Mayor Wagoner made a motion to approve \$300 to pay Dependable Data for the printing of the property tax postcards; Commissioner Stamper seconded the motion; all in favor; motion passed.
- **City Clerk Report:** Commissioner Stanley made a motion to approve up to \$300 to have the printer at city hall serviced by EBM; Commissioner Halsey seconded the motion; all in favor; motion passed.
- **City Clerk Report:** Commissioner Stamper made a motion to approve \$2821.10 to pay the outstanding Kentucky Public Pensions Authority invoices; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passed.
- Commissioner Stamper made a motion to adjourn the meeting at 7:20 p.m.; Commissioner Epperson-Stanley seconded the motion; all in favor; motion passes.
