Regular Meeting Minutes Monday, November 22, 2021 City Hall @ 6:00pm

☐ CALL TO ORDER

- Mayor Wagoner called the November 22, 2021, Regular Meeting to order at 6:00 p.m.
- Mayor Wagoner invited everyone to participate in a moment of silence.
- · City Clerk Centers conducted the roll call.

☐ ROLL CALL

- · Mayor Wagoner determined a quorum was present.
- Mayor Wagoner asked if any of the visitors have a comment to please limit to 3 minutes.
- Commissioner Stamper made a motion to approve the minutes for the October 25, 2021, regular meeting; Commissioner Halsey seconded the motion; all in favor; motion passed.
- Commissioner Stamper made a motion to accept the financial reports with the addition of the unpaid bill for Attorney Jason Obermeyer in the amount of \$953.91; Commissioner Halsey seconded the motion; all in favor; motion passed.
- Morgain Patterson with the Kentucky League of Cities explained the premium pay package for city employees with the ARPA money. All first responders are eligible for this, and it must be wholly additive to the pay, not a replacement pay. It must be added onto the hourly wage, and it can be capped at a certain amount. Regarding premium pay for the city clerk an executive order must be passed by the city for documentation for the treasury when the audit is performed. The premium pay can only be given to city employees, not contract employees.
- City Attorney: City Attorney explained the Opioid Settlement that has been issued against the manufacturer and distributors. The city has no choice in the matter as this was undertaken by the State of Kentucky. Even if the city recovers any monies, 50% of all funds recovered will go to the state and then 50% in a pot for the cities to request. It has been settled and the first payment is scheduled for April of 2022. He suggests going forward and signing off on this issue. Morgain Patterson suggested reaching out to the County Judge executive regarding county agreements on the Opioid Settlement.

- City Attorney: The property that the city salt shed sits on does not have a current deed on file. Attorney Obermeyer is working with a previous city attorney regarding this issue.
- City Attorney: He requested an advance to research the unknown heirs and send warning orders on
 the Fightmaster lots located on Pike Street. He explained that this money will be reimbursed to
 the city whether through the liens or the sale of the lots. Commissioner Stamper made a motion to
 approve \$2300 for Attorney Obermeyer for expenses to research the Fightmaster lots;
 Commissioner Halsey seconded the motion; all in favor; motion passes.
- Public Safety: She stated that she has the current call volume reports in hand for the police
 department. The calls are continuing to increase at Love's, while the police department is also
 responding to assist calls for the Scott County Sheriff's Department. Chief Bruner stated that the
 radar will be moved from the Crown Victoria cruiser and installed in the new Tahoe. The new
 Tahoe will be equipped like the other Tahoe. Lighting is extremely important for safety issues for
 the officers.
- Public Safety: Commissioner Stamper made a motion to complete outfitting the new Tahoe for \$17,474.00 at L&W in Lawrenceburg; Commissioner Halsey seconded the motion; roll call vote; motion passes.

- Public Works: Commissioner Epperson-Stanley is absent. Clerk Centers stated that the
 maintenance man is requesting to purchase two snow shovels, one for City Hall and one for the
 Police Department. Mayor Wagoner made a motion to approve \$50 for the purchase of two snow
 shovels; Commissioner Stamper seconded the motion; all in favor; motion passes.
- Parks & Recreation: Commissioner Stamper explained that out of the \$500 approved previously
 to purchase Christmas décor for City Hall, only \$120 was used. Mayor Wagoner made a motion
 to approve \$350 for the Christmas event budget; Commissioner Stamper seconded the motion; all
 in favor; motion passes.
- Parks & Recreation: Mayor Wagoner approved \$382 from AAA State of Play to purchase two
 replacement swings for Veteran's Park; Commissioner Halsey seconds the motion; all in favor;
 motion passes.
- Streets, Trails and Walkways: Mayor Wagoner reminded everyone of the snow removal contract
 that the City has with Seasons Lawncare. Since the snow removal cost was under \$30,000 last
 year, he suggested renewing the contract for another year. Attorney Obermeyer read the contract.
 Commissioner Stamper made a motion to renew the contract for another year; Commissioner
 Halsey seconded the motion; all in favor; motion passes.
- City Clerk: She requested approval to purchase business cards for herself, Chief Bruner and
 Officer Lawson. Mayor Wagoner made a motion to approve \$250 for the purchase of business
 cards for Laura Centers, Chief Bruner and Officer Lawson; Commissioner Stamper seconded the
 motion; all in favor; motion passes.

- City Clerk: She requested approval to renew both of the city po boxes as the yearly rental is up.
 Commissioner Stamper made a motion to approve \$154 to renew the po boxes; Commissioner Halsey seconded the motion; all in favor; motion passes.
- City Clerk: The city currently has 617 hotspots out.
- Mayor Wagner made a motion to adjourn the meeting at 7:16 p.m.; Commissioner Stamper seconded the motion; all in favor; motion passes.
